Statistics update

INTERNATIONAL MERCHANDISE TRADE STATISTICS

Vanuatu National Statistics Office (VNSO) from 2020 is giving its International Merchandise Trade Statistics (IMTS) an improved form and more information with an intent to satisfy user demands. The new and improved IMTS includes trade classified using the internationally recommended:

- Harmonised System (HS);
- Standard International Trade Classification (SITC); and
- Broad Economic Category (BEC).

It contains data on imports, exports and re-exports by:

- Principal imports, exports and re-exports;
- Major trading partners; and
- Major regions Vanuatu trades with.

A table has been included on the mode of transport used for trading.

A valuable addition to the list of IMTS tables is the retained imports that have been used to calculate the:

- Consumption goods;
- Intermediate goods; and
- Investment goods.

The new set of tables will allow better comparison of Vanuatu IMTS regionally and internationally.



APRIL 2021 – PROVISIONAL HIGHLIGHTS

April 2021 compared to April 2020

Merchandise Export

The total value of merchandise exports increased by 67 percent or (VT 180 million) from VT 270 million to VT 450 million in April 2021, mainly due to a huge drop in re-exports by 75 percent or (VT 34 million) over April 2020. Domestic export earnings (excluding re-exports) for April 2021 stood at VT 439 million, increased by 95 percent or VT 214 million over April 2020. (*Refer to Table 1&3*). This increase was driven by two main export categories:

- ♦ (HS Section II: 06-14) Vegetable products
- ♦ (HS Section I: 44-46) Wood, cork & articles thereof & plaiting material

Merchandise Import

The total value of merchandise imports decreased by 17 percent or (VT 504 million) to VT 2,460 million in April 2021 compared to VT 2,964 million in April 2020. (*Refer to Table 1 & 2*).

The monthly decrease was driven by three main import categories:

- ♦ (HS Section V: 25-27) Mineral Products
- ♦ (HS Section 1: 01-05) Live animals:animal products
- ♦ (HS Section IV: 01-05) Prepared foodstuff and beverages, spirits and tobaccos

Trade Balance

The total value of merchandise import stood at VT (2,460 million), exceeded that of export VT 450 million by resulting in a deficit of VT (2,010 million) in April 2021.(*Refer to Table 1*)

EXPORT

By main commodities: significant contributors to the rise in export in April 2021 were: copra reording the largest shipment at VT 124 and wood at VT 52 million, followed by coconut oil, coffee and other products that made up VT 53 million altogether of the exported goods over April 2020. Other products comprised mainly of machinery & electrical appliances (excavator accessories). The decline (-75) percent in re-exports is also attributable to the export total value in April 2021. Nevertheless, kava exports indicated a slight decrease by 1 percent compared to April 2020. It contributed the largest share to total exports by 37 percent in April 2021. The bulk of kava were exported to Fiji, New Caledonia and the United States of America representing respectively 44, 33 and 21 percent share to the total of kava exports in April 2021 (*Refer to Table 6*)

Main export market destination: registered Philippines with the largest share in April 2021 representing 24 percent of the total exports followed by Fiji, New Caledonia and China representing respectively 17, 14 and 12 percent share of total merchandise exports value. (*Refer to Table 8*). The top two region with highest shares to the total export value in April 2021 were Asia and Oceania representing respectively 48 and 44 percent to the export value. (*Refer to Table 9*).

Mode of transport: accounted for 87 and 11 percent respectively for "Sea" and "Air" to total exports value in April 2021. The "Sea" transport also increased by 93 percent or VT 188 million compared to April 2020. (*Refer to Table 10*).

IMPORT

Main commodities: that decreased in April 2021 were: Petroleum oils and oils obtained from bituminous minerals, 79 percent or VT 843 million, followed by petroleum gases and other gaseous hydrocarbons, 16 percent, fish and crustaceans, molluscs and other aquatic invertebrates 56 percent, meat and edible offal poultry at 30 percent, milk and cream at 20 percent, alcoholic drinks and bread pastry, cakes, biscuits and other bakewares representing respectively 31 and 35 percent over April 2020 (*Refer to Table 7*).

Major source markets : Australia leading by 22 percent and china by 13 percent, followed by New Zealand and Fiji representing 12 percent respectively and Singapore at 11 percent, altogether, accounting for 70 percent share to total imports value in April 2021.(*Refer to Table 8*). By region, imports recorded a decline by 38 percent in Asia in April 2021 compared to April 2020. Meanwhile, Oceania records the highest share of the month by 49 percent to total imports in April 2021. (*Refer to Table 9*.

Mode of Transport shares to total imports registered 77 percent by "Sea" and 10 percent by "Air" in April 2021. However, "Sea" transport decreased by 24 percent or VT 598 million in April 2021 over April 2020. (*Refer to Table 10*)

End use categories of retained imports (BEC) comprised of consumption goods at 36 percent or (VT 894 million) 12 percent point higher over the previous month, intermediated goods at 32 percent or (VT 791 million) and capital goods at 18 percent or (VT 443 million) to total retained imports in April 2021. (*Refer to Table 14*)

Balance of trade	Balance of trade of goods is the net sum of exports and imports of goods.
Datance of trade	
	 Surplus denotes a positive trade balance which indicates that the value of exports has exceeded the value of imports. Deficit denotes negative trade balance which indicates that the value of imports has exceeded the value of exports.
BEC	Broad Economic Category: a classification that groups commodities according to its end use.
CIF	Cost, insurance and freight : includes the transaction value of the goods, insurance and freight to deliver the goods from the border of the exporting country to the border of the importing country.
FOB	Free on board : includes the transaction value of the goods and the value of services performed to deliver goods to the border of the exporting country.
HS	Harmonized Commodity Description and Coding System : is a classification of exports and imports of goods. The latest version is '2017' and the custodian of it is the World Customs Organisation (WCO). Vanuatu uses the Vanuatu Harmonized System based off the WCOs HS17. Vanuatu HS is closely aligned to the Pacific HS2017. For HS Sections and Chapters refer to Appendix 3.
IMTS	International merchandise trade statistics : records all goods, which add to or subtract from the stock of material resources of a country by entering (imports) or leaving (exports) its economic territory.
International merchandise trade	 International merchandise trade: is the exchange of goods across international borders. Exports refer to goods from Vanuatu purchased by another country.
