Statistics update

INTERNATIONAL MERCHANDISE TRADE STATISTICS

Vanuatu National Statistics Office (VNSO) from 2020 is giving its International Merchandise Trade Statistics (IMTS) an improved form and more information with an intent to satisfy user demands. The new and improved IMTS includes trade classified using the internationally recommended:

- Harmonised System (HS);
- Standard International Trade Classification (SITC); and
- Broad Economic Category (BEC).

It contains data on imports, exports and re-exports by:

- Principal imports, exports and re-exports;
- Major trading partners; and
- Major regions Vanuatu trades with.

A table has been included on the mode of transport used for trading.

A valuable addition to the list of IMTS tables is the retained imports that have been used to calculate the:

- Consumption goods;
- Intermediate goods; and
- Investment goods.

The new set of tables will allow better comparison of Vanuatu IMTS regionally and internationally.



JUNE 2021 – PROVISIONAL HIGHLIGHTS

June 2021 compared to June 2020

Merchandise Export

The total value of merchandise exports stood at VT 721 million in June 2021, an increase in value by 33 percent or VT 177 million compared to VT 544 million in June 2020. Domestic export earnings (excluding re-exports) for June 2021 stood at VT 708 million, increased by 40 percent or VT 204 million over June 2020. (*Refer to Table 1&3*). This increase was driven by two main export categories:

- (HS Section II: 06-14) Vegetable products
- (HS Section IV: 16-24) Prepared foodstuff and beverages, spirits and tobaccos

Merchandise Import

The total value of merchandise imports slightly decreased by 5 percent or (VT 141 million) to VT 2,672 million in June 2021 compared to VT 2,814 million in June 2020. (*Refer to Table 1&2*).

The monthly decrease was driven by three main import categories:

- (HS Section IV: 16-24) Prepared foodstuff and beverages, spirits and tobaccos
- (HS Section V: 25-27) Mineral Products
- (HS Section XV1: 50-63) Textiles & textile articles

Trade Balance

The total value of merchandise import stood at (VT 2,672 million), exceeded that of export VT 721 million, resulting in a deficit of (VT 1,951) million in June 2021. (*Refer to Table 1*)




Figure 1: Balance of Trade - All items (Million Vatu)

EXPORT

By main commodities: Copra and kava were major contributors to the rise in total export value in June 2021, accounting for 63 percent share, followed by cocoa, tuna fish, wood and other products accounting for 35 percent share altogether in June 2021. Oher products comprised mainly of scrap metals, game kits of gaming machines and personal effects exports. Most of the copra exports went to Bangladesh, representing 33 percent share to total exports, while the bulk of kava were exported to Auatralia, New Caledonia, United States of America Fiji, New Zealand and Kiribati representing respectively 48,18,17,16 and 1 percent share to the total of kava exports in June 2021. (*Refer to Table 6*)

Main export market destination: registered Philippines leading with the largest share in June 2021 representing 27 percent of the total exports followed by Australia at 21 percent, China at 15 percent while the remaining countries made up 37 percent share to the total exports value in June 2021. (*Refer to Table* 8). The top two region with highest shares to the total export value in June 2021 were Asia and Oceania representing 57 and 36 percent respectively. (*Refer Table 9*).

Mode of transport: accounted for 77 and 21 percent share respectively for "Sea" and "Air" to total exports value in June 2021. The "Sea" transport recorded a significant increase in value by 57 percent, reflecting an excess of VT 202 million compared to June 2020 when it stood at VT 353 million. (*Refer Table 10*).

IMPORT

Main commodities: that decreased in value in June 2021 were: cement at 95 percent, diesel or semi diesel engines 89 percent, other furniture and parts thereof, 86 per cent, petroleum gases and other hydro carbons at 84 percent, followed by wheat and rice representing 59 and 55 percent respectively over June 2020. (*Refer to Table 7*). The largest commodity share to total imports in June 2021 was from other imports in other import categories such as : fruits and vegetable juices (hs 2009*), chocolates and other food preparation containing cocoa, (hs 1806), Sugar confectionery inc white chocolates not containing cocoa, (hs 1704 & 2106) respectively and other fruits and nuts, accounting to almost 28 percent share to total imports value in June 2021.

Major source markets : Australia leading by 23 percent and New Zealand by 15 percent, followed by China and Singapore representing 14 percent respectively and Fiji at 8 percent, altogether, accounting for 74 percent share to total imports value in June 2021. (*Refer to Table 8*). By region, Oceania represented the highest share of the month by 48 percent, followed by Asia at 45 percent to total imports in June 2021. (*Refer to Table 9*).

Mode of Transport shares to total imports registered 77 percent by "Sea" and 10 percent by "Air" in June 2021. Compared to June 2020, Sea transport decreased in value by VT 251 million in June 2021. (*Refer to Table 10*)

End use categories of retained imports (BEC) comprised of consumption goods at 30 percent or (VT 810 million), 4 percent point higher over the previous month, intermediated goods at 29 percent or (VT 772 million) and capital goods at 23 percent or (VT 603 million) to total retained imports in June 2021. (*Refer to Table 14*)

Balance of trade	Balance of trade of goods is the net sum of exports and imports of goods.
Datance of trade	
	 Surplus denotes a positive trade balance which indicates that the value of exports has exceeded the value of imports. Deficit denotes negative trade balance which indicates that the value of imports has exceeded the value of exports.
BEC	Broad Economic Category: a classification that groups commodities according to its end use.
CIF	Cost, insurance and freight : includes the transaction value of the goods, insurance and freight to deliver the goods from the border of the exporting country to the border of the importing country.
FOB	Free on board : includes the transaction value of the goods and the value of services performed to deliver goods to the border of the exporting country.
HS	Harmonized Commodity Description and Coding System : is a classification of exports and imports of goods. The latest version is '2017' and the custodian of it is the World Customs Organisation (WCO). Vanuatu uses the Vanuatu Harmonized System based off the WCOs HS17. Vanuatu HS is closely aligned to the Pacific HS2017. For HS Sections and Chapters refer to Appendix 3.
IMTS	International merchandise trade statistics : records all goods, which add to or subtract from the stock of material resources of a country by entering (imports) or leaving (exports) its economic territory.
International merchandise trade	 International merchandise trade: is the exchange of goods across international borders. Exports refer to goods from Vanuatu purchased by another country.
