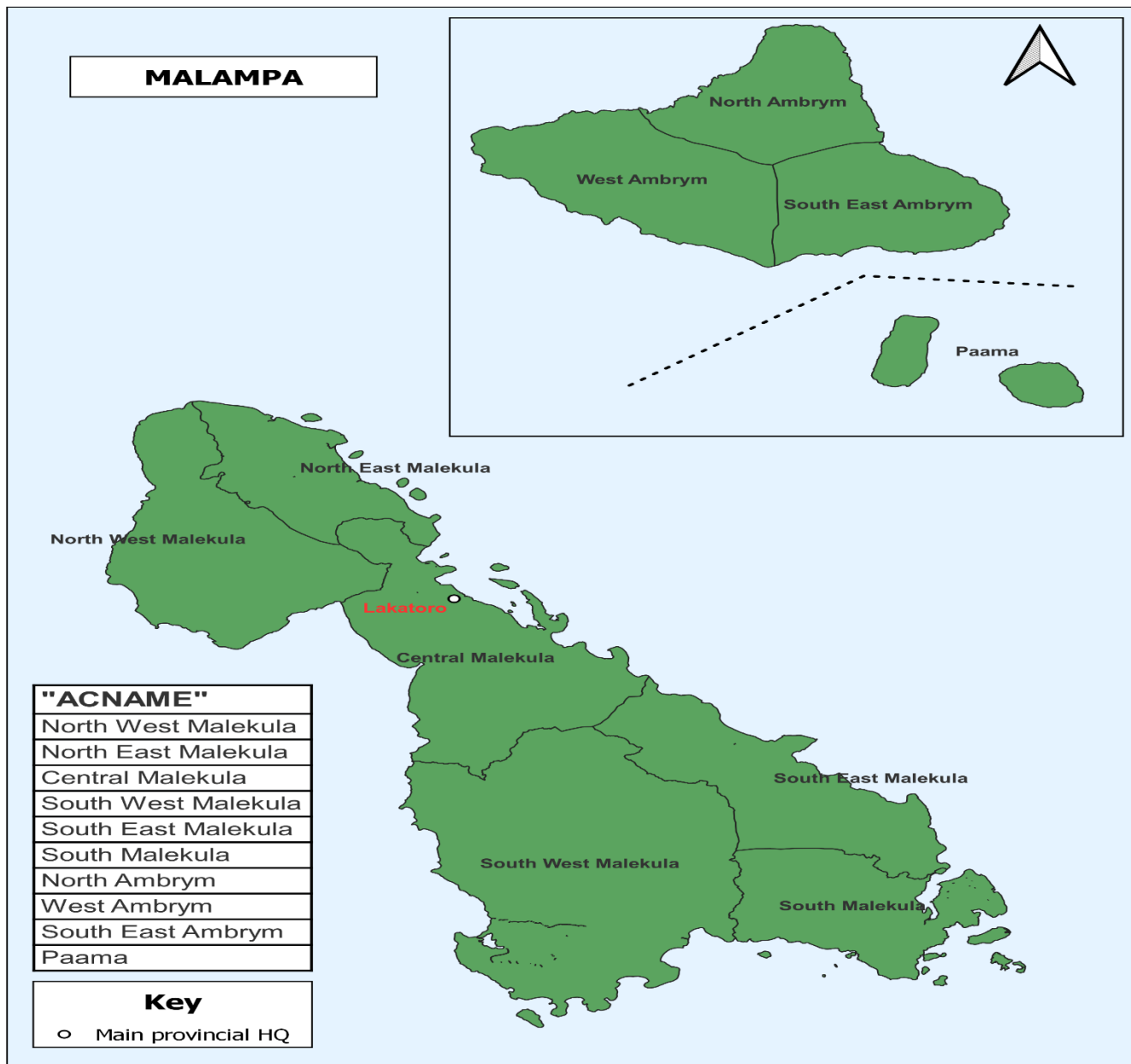

Malampa is one of the six provinces of Vanuatu, located in the center of the country and consisting of three main islands and covering an estimated land area of 2,779 km square. It includes a number of other islands – the small islands of Uripiv, Norsup, Rano, Wala, Atchin and Vao off the coast of Malekula, and the volcanic island of Lopevi (currently uninhabited). Also included are the Maskelynes Islands and some off shore islands along the south coast of Malekula.

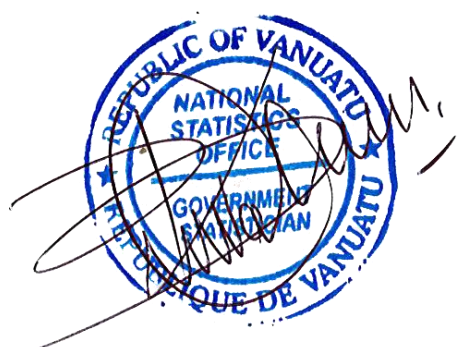

Visitors visiting Malampa Province from 2015 to 2020 highlighted the highest visitors by **25%** in 2018 compare to the least of **3%** of visitors in 2020 which indicates a decline due to COVID-19 global pandemic lockdown.

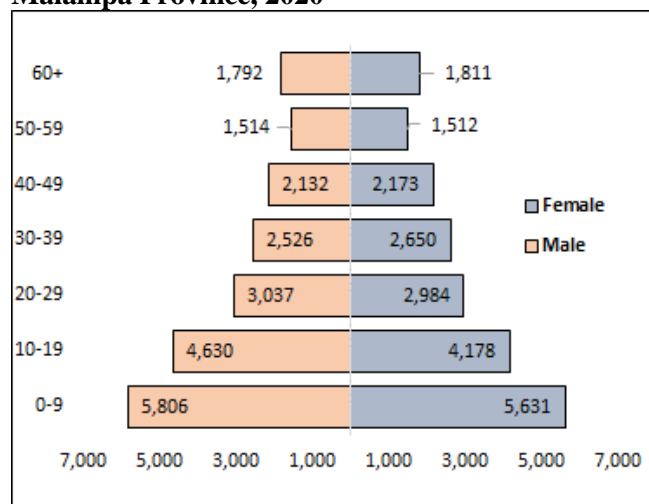

1. Population

1.1 Population of Malampa Province

The 2020 population projections estimated that around 42,499 people were living in Malampa province of which 51% were male and 49% female. Key feature of the Malampa population is that it has a young age structure with 39% of the population aged under 15 years and only 9% aged over 60 years as shown by the population pyramid.

1.2 Population Density

Density is a good indicator of how population are distributed by area. A number higher than 12 persons per km² shows that the area is crowded.

Malampa province has a total land area of 2,779 km² and a total population of 42,499 according to 2020 population census. An indication that the average population density for Malampa province in 2020 was 15 people per km².

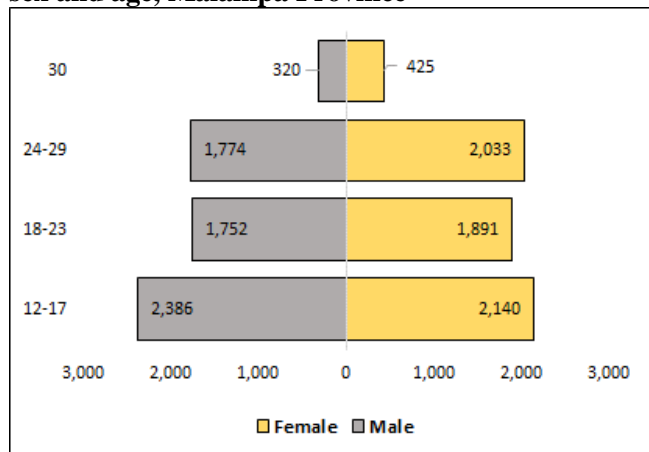

2. Youth

2.1 Youth Population

The age group of 12-30 years is used in the official youth policy and accounts for 12,721 of young people in Malampa Province. According to the 2020 Population projections 49% (6,231) were males compared to 51% (6,489) females. The youth population represents 30% of the total population of Malampa province.

Figure 2.1. 2020 Youth population projections by sex and age, Malampa Province



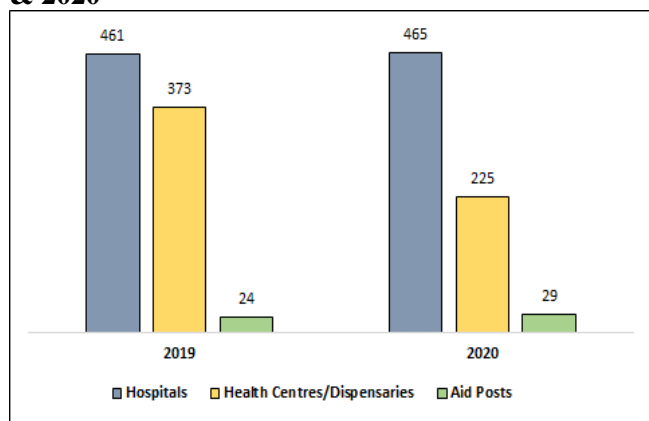

3. Health

3.1 Deliveries (Births)

Total deliveries recorded in hospital in the year 2019 shows hospital was higher by 461 followed by health centers with 373 deliveries. In 2020, hospital also record a high number with 465 deliveries followed by health centers and dispensaries with 225 deliveries. Still more labor and delivery within hospitals than centers/dispensaries.

Figure 3. 1. Total birth deliveries in Malampa, 2019 & 2020

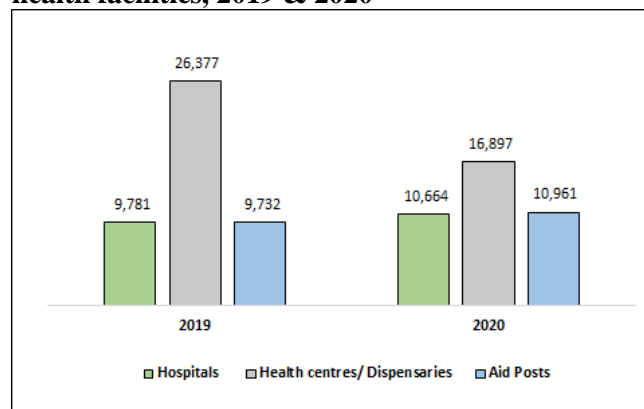

3.2 Outpatient Consultations

Outpatient consultations for all health facilities shows health centers and dispensaries in 2019 was higher by 26,377 consultations compared to 16,897 in 2020. The figure indicates more patients access health services from the health centres and dispensaries in 2019 and 2020 compared to hospital and aidposts.

Figure 3. 2. Malampa outpatient consultations by health facilities, 2019 & 2020



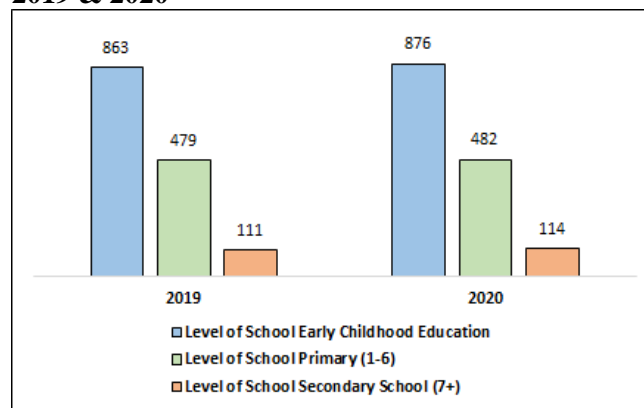

Figure 4. 1. Total number of schools in each type, 2019 & 2020

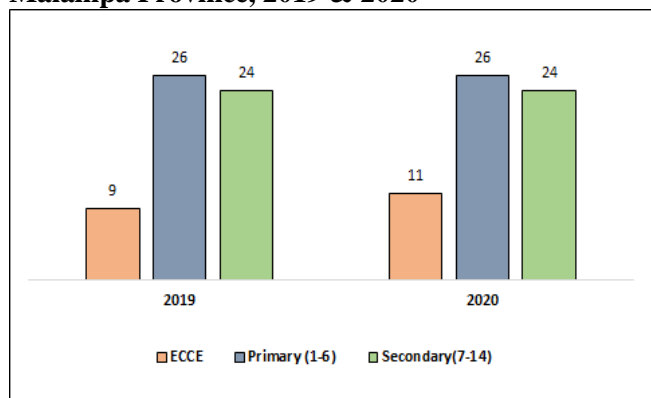

4.2 Student-Teacher Ratio

According to the MoET regulation order number 44 of 2005, the national Student-Teacher ratio by education level is 15 pupils to 1 teacher in ECE, 1 teacher to 30 pupils in Primary, and 25-30 students per teacher in Secondary level. For the ECE level, the student-teacher ratio was 9 in 2019 while 11 in 2020. Primary level, the student teacher ratio was 26 in 2019 and same as 2020. Secondary level with similar ratio in 2019 and 2020.

Figure 4. 2. Student teacher ratio by school type in Malampa Province, 2019 & 2020

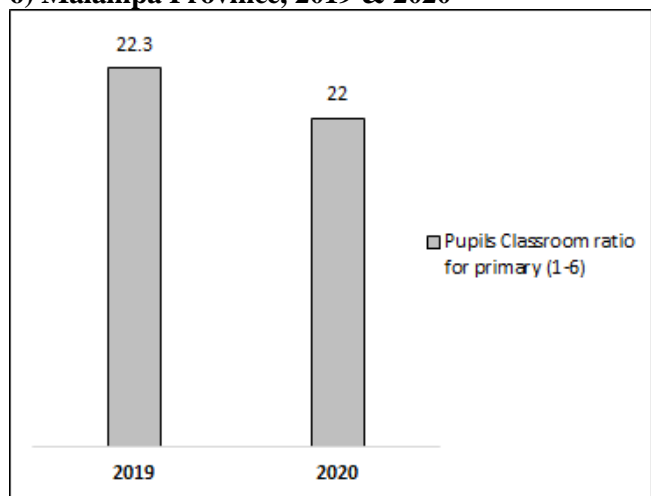

4.3 Pupil Classroom Ratio for Primary Schools

In accordance to VEMIS digest annual reports, Student Classroom Ratio (SCR) is defined as average number of pupils per classroom, and in a school year the ideal size should be 30 students per classroom. The 2019 and 2020 year shows that Malampa province is below the standard ideal size at 22 students per classroom.

Figure 4. 3. Pupils' classroom ratio for primary (1-6) Malampa Province, 2019 & 2020

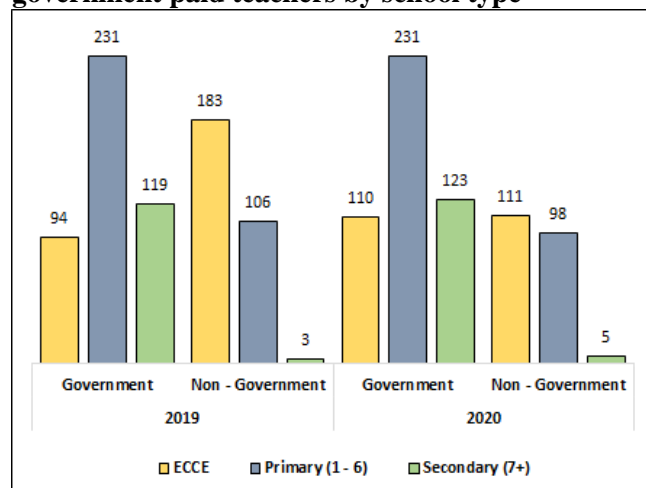

4.4 Number of government and non-government paid teachers by school type

Year 2019 and 2020 records the highest number of government teachers that teacher's primary (1-6) with paid salaries. Still government has the highest indication with more than 50% of paid primary teachers during 2019 and 2020.

Figure 4. 4. Number of government and non-government paid teachers by school type

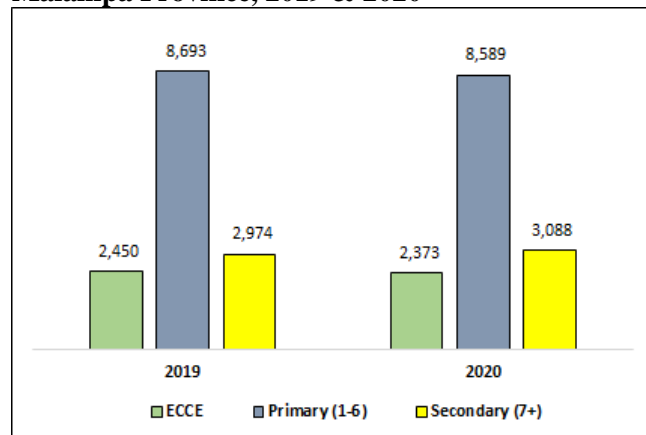

4.5 Total enrolment by school type

Enrolment in Malampa province indicated that primary (1-6) has the highest number of student enrolment in 2019 with 8,693 students compared to 2020 with 8,589 students. Secondary (7+) in 2020 with an increase of 3,088 compared to 2019 with 2,974. The least is ECCE with 2,450 in 2019 compare to 2,373 in 2020.

Figure 4. 5. Total enrolment by school type in Malampa Province, 2019 & 2020



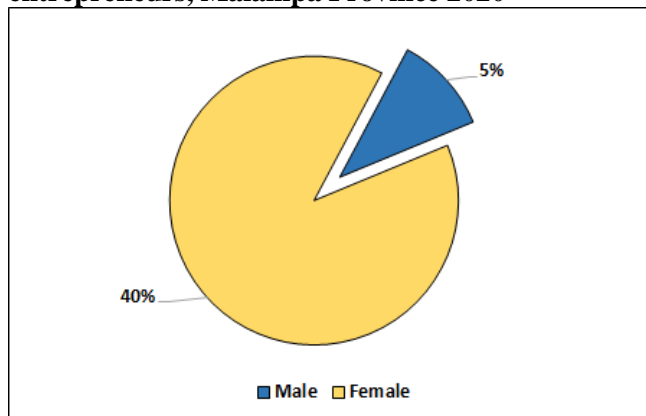

Figure 5.1. Participation of male and female entrepreneurs, Malampa Province 2020



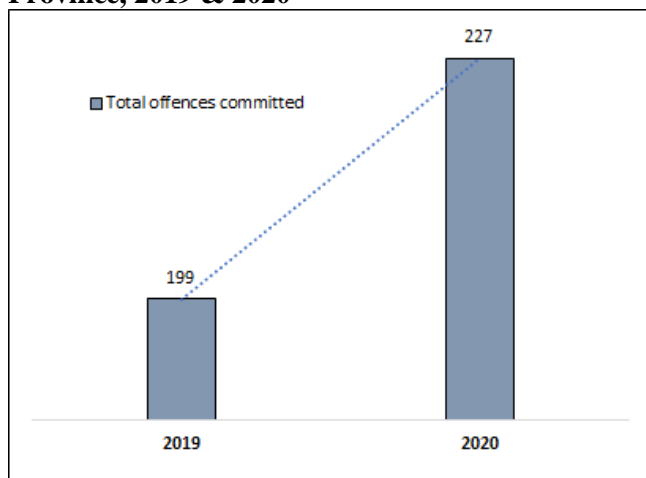

6.1 Crime Rates

In 2019, the total crimes committed in Malampa Province was 199 follows by an increase of 227 in 2020. An indication of 6.6% of crime rates from 2019 to 2020

6.2 Offense by type

The following table ranks the “top 10” type of crimes committed during 2019 & 2020. Intentional assault recorded the highest at 73 cases followed by 60 cases for Domestic violence offences and 46 cases are shown for malicious damage/destruction to property. The least committed crime was Court Protection order at 15 cases recorded.

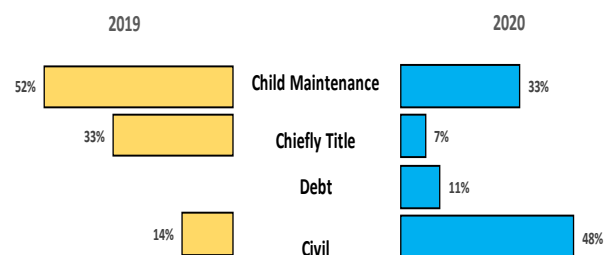

6.3 Court cases by type

The highest island court cases in Malampa province in 2019 was Child Maintenance case with 52% while Chiefly title with 33% and Civil with 14%. In 2020 the highest case was Civil with 48%, Child Maintenance with 33%, Debt with 11% and Chiefly title with 7%.

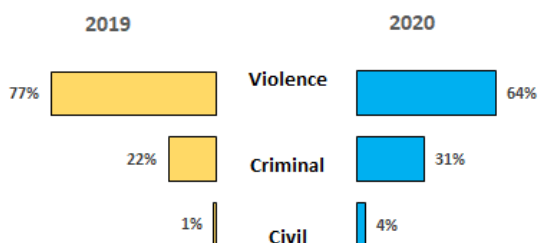
Figure 6. 2. Percentage share of island court cases by case type, Malampa Province 2019 & 2020

Magistrate Court cases in Malampa province in 2019 highlighted an increase of 77% of violence cases compare to a decline of 13% in 2020 representing 64% of violence cases. Criminal cases were 22 % in 2019 and increases by 31%in 2020. Civil was 1% in 2019 compare to an increasing 4% in 2020.

Figure 6. 3. Percentage share of Magistrate Court cases by type, Malampa 2019 & 2020



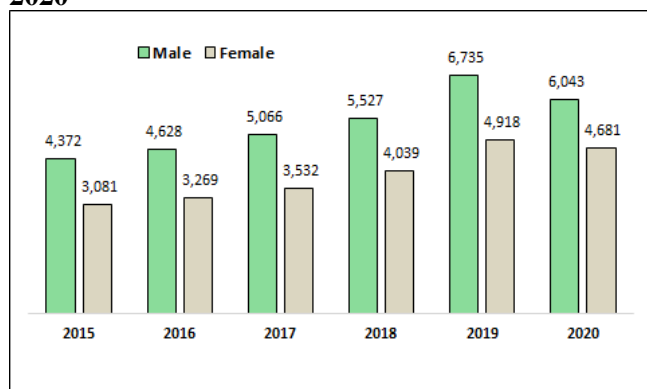

7. Employment

7.1 VNPF Membership

A total of 55,891 members recorded from 2015 to 2020. The contributing members indicated that still male outnumbered female. Contributing members shown a continuous increase over the years with the highest in 2019 with a total of 11,653 members representing 6,735 male and 4,918 female. Moreover, within the period of 2015 to 2020, male represented 58% (32,371) with female 42% (23,520) of the total members contribution.

Figure 7.1. Total VNPF contributing members / Formal employment by sex, Malampa from 2015 - 2020



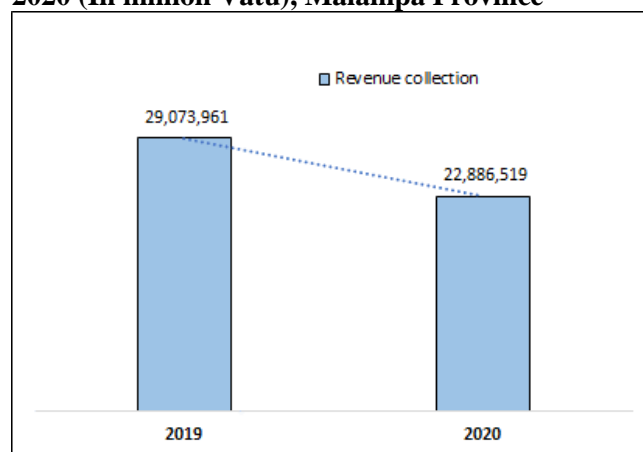

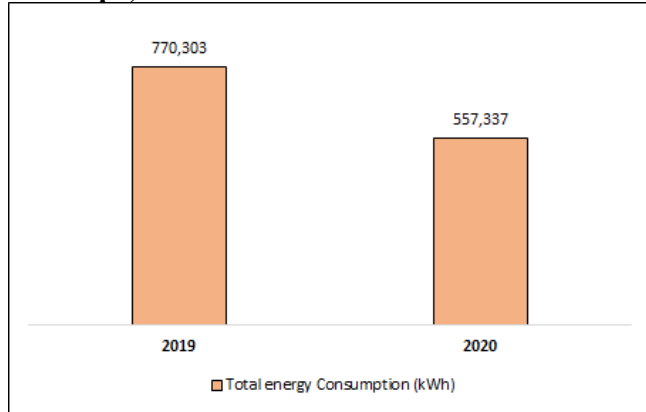

Figure 9.1. Total energy consumption (kwh), Malampa, 2019 & 2020



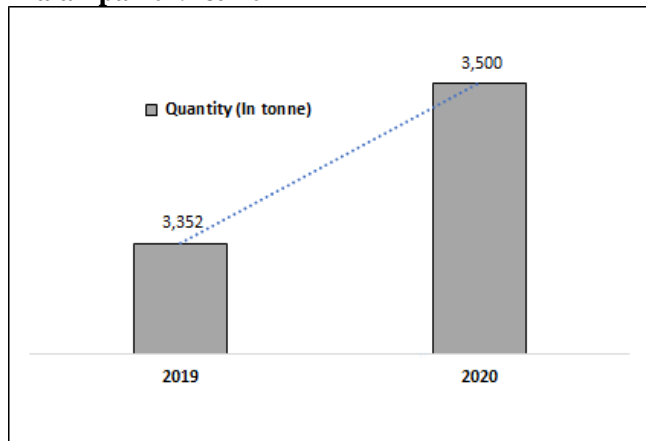

Figure 10. 1. Total copra export (in Tonnes), Malampa 2019 & 2022

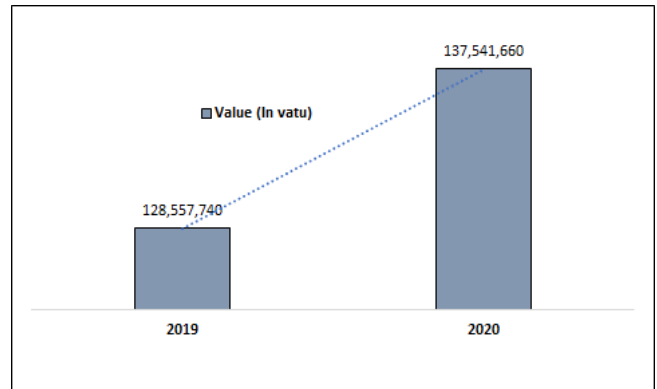

Figure 10. 2. Total copra export by Value, 2019 & 2020

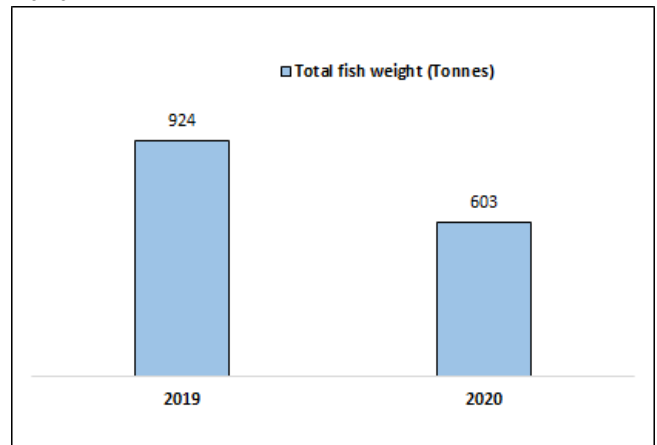

Figure 10. 3. Total fish weight (in Tonnes), 2019 & 2020

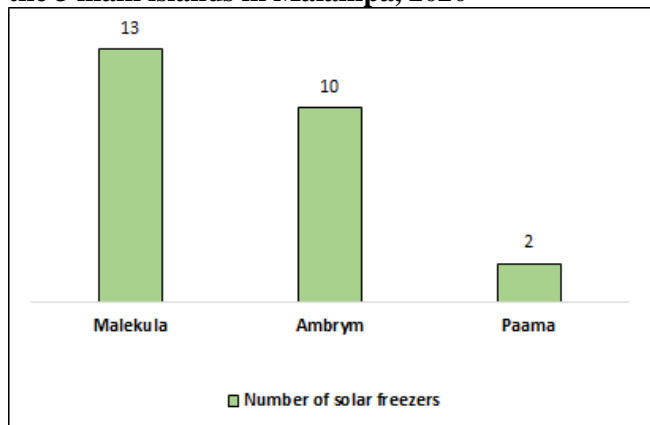

Figure 10. 4. Number of solar freezers install within the 3 main islands in Malampa, 2020



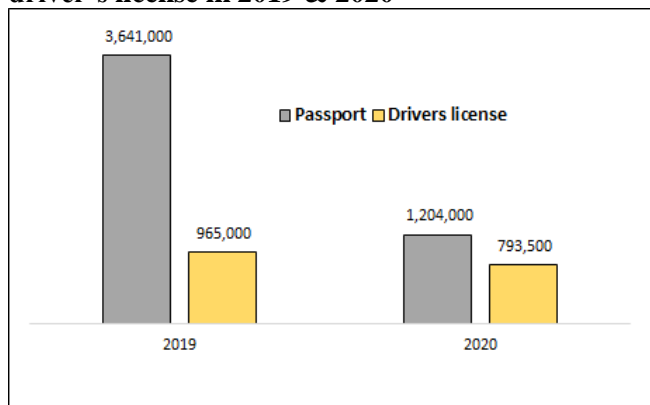

Figure 11.1. Revenue collected from passport & driver’s license in 2019 & 2020



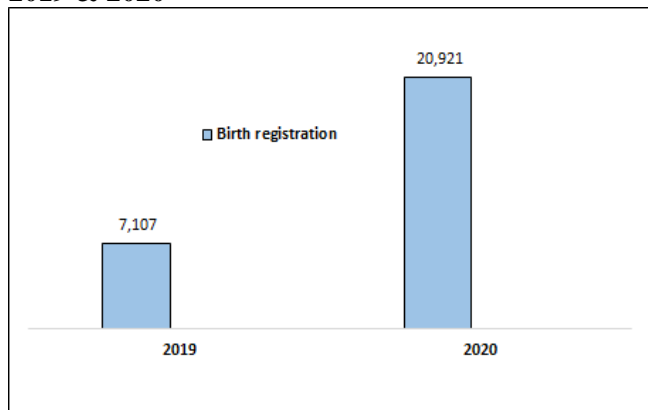

Figure 12. 1. Total birth registration in Malampa, 2019 & 2020

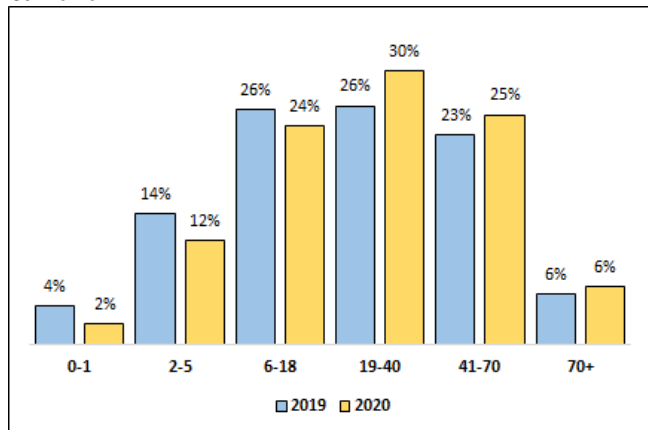

Figure 12. 2. Birth registration by age group, 2019 & 2020



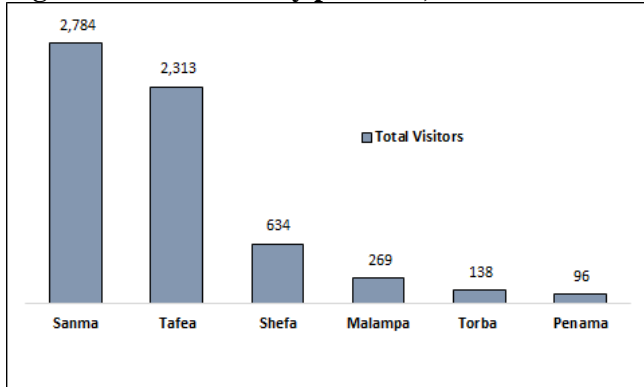

Figure 13. 1. Visitors by province, 2020

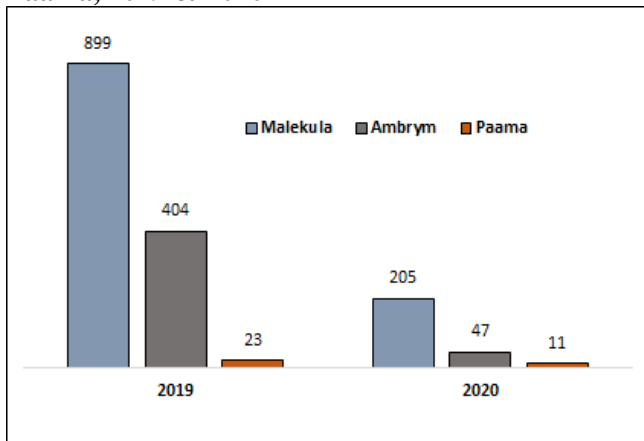

Figure 13. 2. Visitors to Malekula, Ambrym & Paama, 2019 & 2020

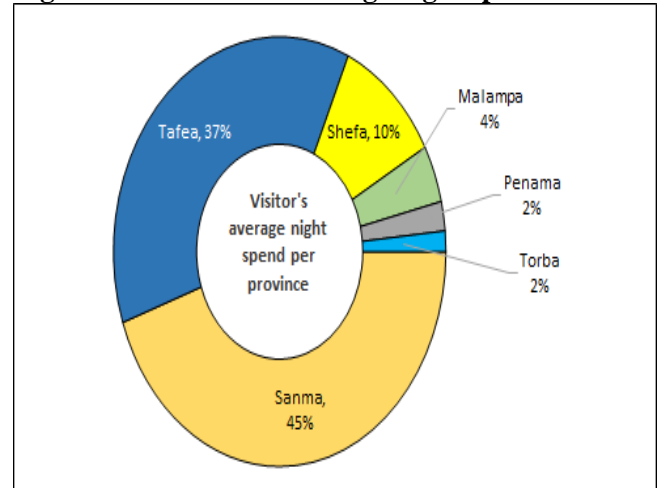

Figure 13. 3. Visitors' average night spent



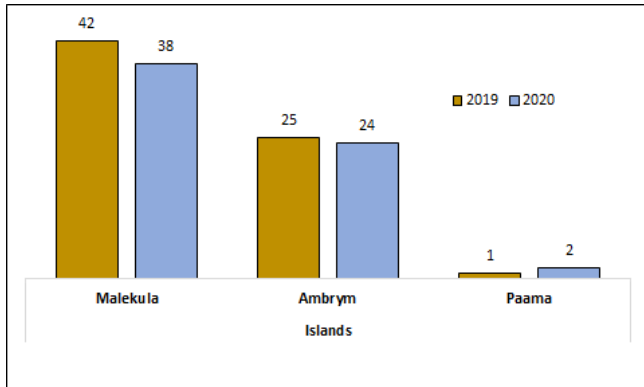

14. Cooperatives

14.1 Active Cooperatives

Malekula with the highest number of active coops compare to Ambrym and Paama. However, there has been a steadily growth of active coops as indicated by Malekula with 38 active coops in 2020 compare to 42 in 2019; Ambrym registered 24 coops in 2020 and 25 in 2019 while Paama added 2 active coops in 2020.

Figure 14. 1. Total active cooperatives in Malampa, 2019 & 2020

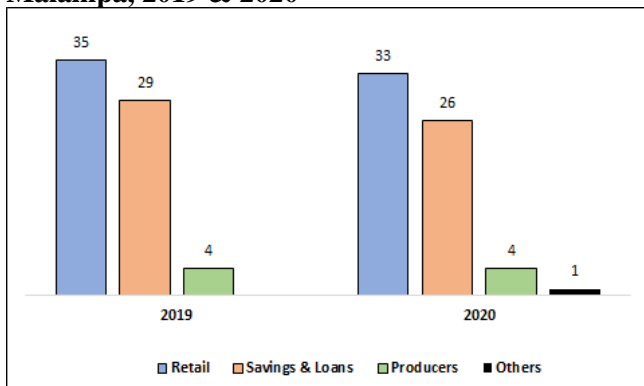

14.3 Cooperative Membership

Total membership, turnover and the share of dividend to members for Malampa Province has shown a decrease in 2020:

- An increase Membership of 5,157 members in 2019 compare to a declining 5,125 membership in 2020.
- The total annual turnover for 2019 was 253,847,208vt, while in 2020 it decreases to 217,746,217vt.
- Total dividend shares to members also decreased in 2020 to 10,633,657.

Provincial Data Challenges

There are several difficulties associated with the analysis of Provincial level Statistics. The coverage of statistical indicators varies within the geographical distribution. Being one of the main contributing factors, the collection and analysis of the statistical data had a great impact from the range of geographical hierarchy from the Area Council level to the Village level resulting in underutilization of statistical reporting. Thus, the snapshots of most of the socio-economic indicators of analyses were from particular areas within the provincial boundaries, used as a representation of the entire province statistical outlook.

Systems of collection and management of statistical information or data across entities is another contributing factor as most of the data providers do not have a proper system of collection and storage of data. Resources, both financial and human resource capacity contribute to the variation of the data collected.

Statistical literacy continues to be another challenge however with the setup of provincial statistical offices, one of the objectives is to promote statistical literacy and the importance on the use of statistics in all levels of decision and policy making.

Key Concepts and Definitions

<i>Domestic Violence</i>	Violent or aggressive behavior within the home, typically involving the violent abuse of a spouse or partner
<i>Energy Consumption Rate</i>	Is the consumption of energy or power and measured in watt-hours
<i>Household</i>	Those persons who usually eat together and share the work of preparing food and/or the cost of work for providing it.
<i>Indicator</i>	An indicator is something that helps you understand where you are, which way you are going and how far you are from where you want to be.
<i>Population Census</i>	A count of a given area resulting in an enumeration of the entire population and the compilation of demography, social and economic information pertaining to that population at a specific time
<i>Population Density</i>	The number of people living per unit area (e.g., Per square km)
<i>Sex Ratio</i>	The ratio of males to females in a population, usually express as the number of males for every 100 females
<i>Statistics</i>	Deals with collection, analysis, interpretation, presentation, and organization of socio-economic data
<i>Student-Teacher Ratio</i>	Expresses the relationship between the number of students enrolled in a school and the number of “full-time equivalent” teachers employed by the school
