The absence of data is primarily attributed to the cyber-attack in October 2022 since the databases were under the government network that was hacked during this time.



We are working with relevant authorities to resolve this and make sure this data is provided in our future reports.

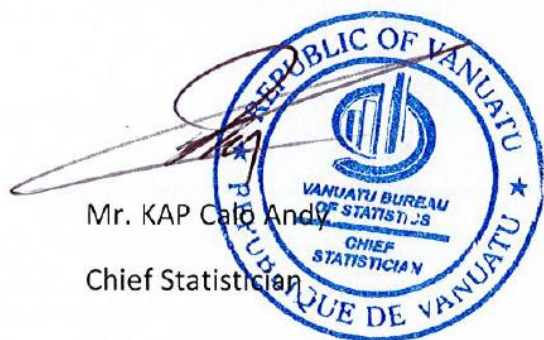

## OVERVIEW

### Cattle Slaughter (refer to table 1.2)

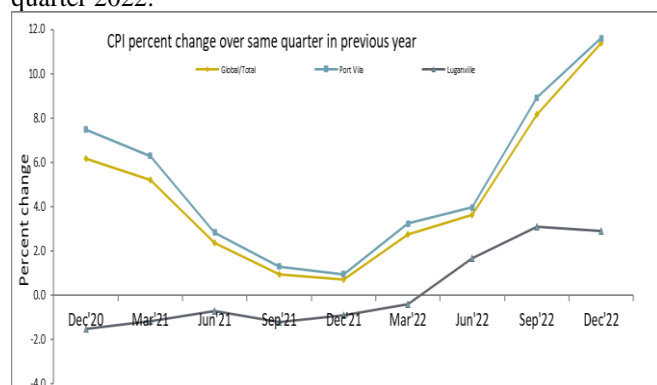
- The total number of heads slaughtered in December quarter of 2022 stood at 2,781 which represent an increase of 14% compared to the previous quarter and it also increased by 18% when compared to the same quarter of the previous year.

### Consumer Price Index (refer to Tables 4.1 and 4.2)

- The Consumer Price Index (CPI) of December quarter 2022 indicated an increase of (+4.4%). Port Vila increased by (+3.9%) and Luganville by (+0.3%) compared to the previous quarter. When compared to the December quarter of 2021, the Vanuatu index increased by (+11.4%). Port Vila index increased by (+11.6%) and Luganville index increased by (+2.9%).

### Inflation Rate

Rate of change: December quarter 2020 to December quarter 2022.



- At the national level, the expenditure groups that contributed to the increase over the same quarter of the previous year were: Food (+15.7%), Transport (+14.9%), Miscellaneous (+14.4%), Housing & Utilities (13.9%), Recreation (+11.0%), Health (+10.0%), Clothing and Footwear (+9.5%), Drinks and Tobacco (+7.8%), Education (+2.7%) and Communication at (+0.1%). The increase in these expenditure groups were driven by the increase in price changes in root crops and fruits and Vegetables, Petrol and diesel, sea fare ( for both region), electricity and water supply, charges medical Prescription drugs and audio-visual computing.

### Summary of Government Revenue and Expenditure

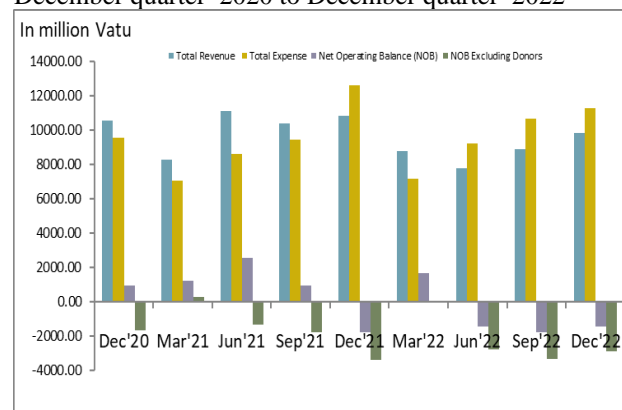
Total Government Operation (TGO) (refer to Table 5.1)<sup>1</sup>

- The total government revenue for December quarter 2022 stood VT 9,797 million of which 85% is recurrent revenue while 15% were grants received from abroad. Total revenue increased by 11% over the previous quarter however it decreased by 9% over corresponding period in 2021.
- The total government expenditure for December quarter 2022 increased by 6% over the previous quarter however it decrease by 11% over the corresponding period in 2021.

### Government Revenue (refer to Table 5.1)

- The total government revenue excluding donors in December quarter 2022 stood at VT 8,348 million. This is an increase of 15% over the previous quarter, however it decreased by 9% over corresponding period in 2021. The total tax revenue collected for December quarter totalled up to VT 5,709 million, it increased by 12% over the previous quarter and it also increased by 25% over December quarter 2021.

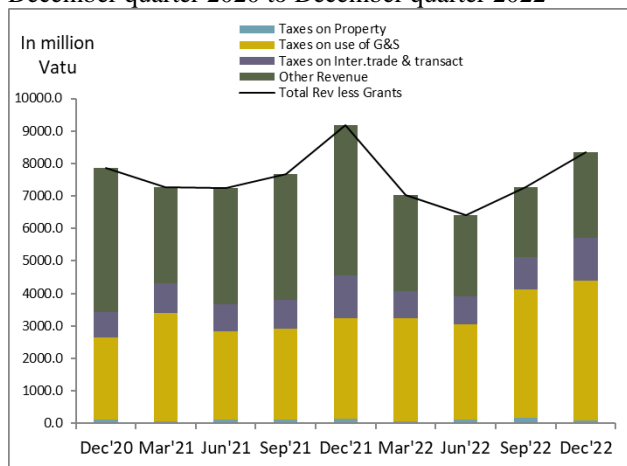

December quarter 2020 to December quarter 2022

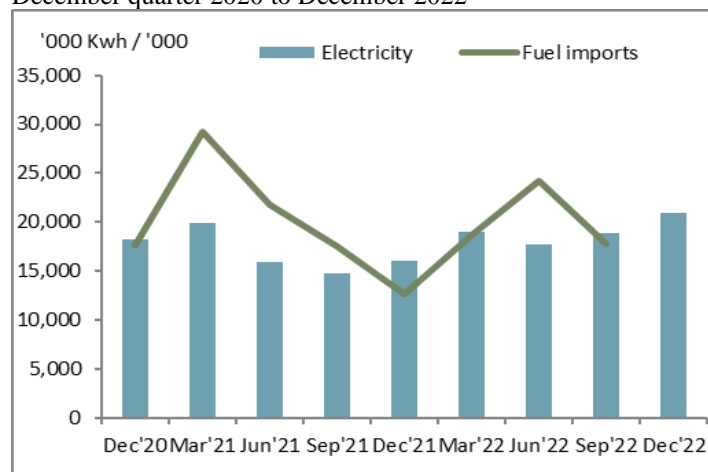

December quarter 2020 to December 2022



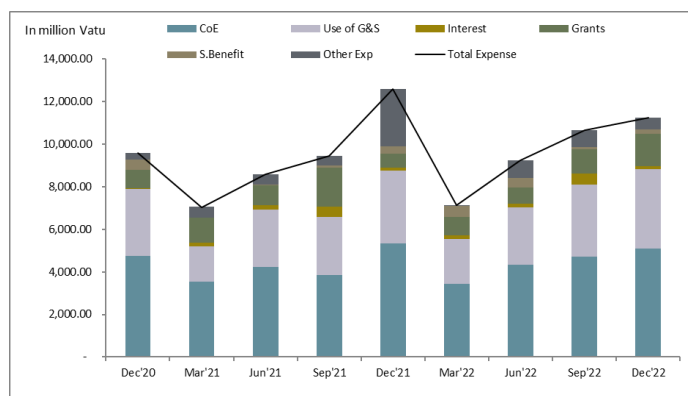
### Government Expenditure (refer to Table 5.1)

- The total government expenditure in December quarter 2022 stood at VT 11,253 million. Compensation of employees made up 45% or VT 5,101 million of total government expenditure in December quarter 2022. This is an increase of 8% over the previous quarter but it decrease by 4% compared to December quarter of 2021.

### Energy consumption (see Table 3)

- Total energy consumed (expressed in kilowatts) for the 4th quarter of 2022 amounted to 20,899, an increase of 11% over the previous quarter and 30% over the same quarter of the previous year.
- The factors contributing to this increase in electricity consumption compared with the corresponding quarter in 2021 were Port vila with 37% and Lakatoro with 34%.

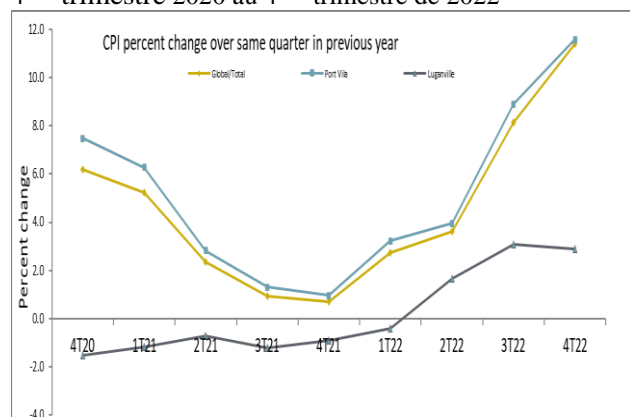
### Indice des prix à la consommation (Voir Tableaux 4.1 et 4.2)

- L'indice des prix à la consommation (IPC) du 4<sup>ème</sup> trimestre de 2022 indique une hausse de (+4,4%). Port Vila a augmenté de (+3,9 %) et Luganville de (+0,3 %) par rapport au trimestre précédent. Par rapport au 4<sup>ème</sup> trimestre de 2021, l'indice Vanuatu a augmenté de (+11,4%). L'indice de Port Vila a augmenté de (+11,6%) et celui de Luganville de (+2,9%).

- Au niveau national, les groupes de dépenses qui ont contribué à l'augmentation par rapport au même trimestre de l'année précédente sont : Alimentation (+15,7%), Transports (+14,9%), Divers (+14,4%), Logement et services publics (13,9%), Loisirs (+11,0%), Santé (+10,0%), Habillement et chaussures (+9,5%), Boissons et tabac (+7,8%), Enseignement (+2,7%), Communication à (+0,1%). L'augmentation des mouvements de prix est due aux changements de prix des produits agricoles et des fruits et légumes, de l'essence et du diesel, des tarifs maritimes (pour les deux régions), de l'électricité et de l'approvisionnement en eau, des médicaments sur ordonnance et de l'informatique audiovisuelle.

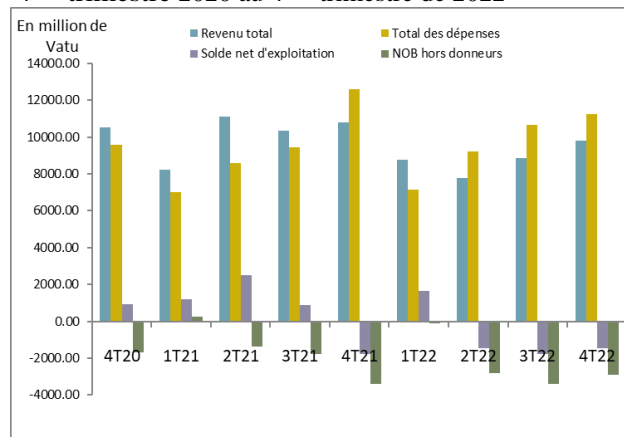
Total des Opérations Gouvernementales (TOG) (voir le tableau 5.1)

- Les recettes totales du gouvernement pour le 4<sup>ème</sup> trimestre de 2022 s'élèvent à 8 348 millions de Vatu, dont 85% sont des recettes récurrentes alors que 15% des subventions reçues de l'étranger. Les recettes totales ont augmenté de 11% par rapport au trimestre précédent, mais ont chuté de 9% par rapport à la période correspondante de 2021.
- Les dépenses publiques totales pour le 4<sup>ème</sup> trimestre 2022 ont augmenté de 6% par rapport au trimestre précédent, mais ont diminué de 11% par rapport à la période correspondante de 2021.

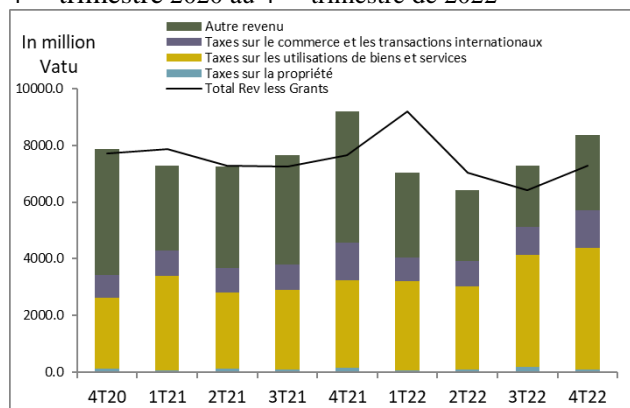
### Recettes publiques (voir tableau 5.1)

- Les recettes totales des administrations publiques, hors donateurs, se sont élevées à 8 348 millions de vatu au cours du 4<sup>ème</sup> trimestre 2022. Il s'agit d'une augmentation de 15 % par rapport au trimestre précédent, mais d'une diminution de 9 % par rapport à la période correspondante en 2021. Le total des recettes fiscales collectées pour le 4<sup>ème</sup> trimestre s'est élevé à 5 709 millions de vatu, soit une augmentation de 12 % par rapport au trimestre précédent et de 25 % par rapport au 4<sup>ème</sup> trimestre de 2021.

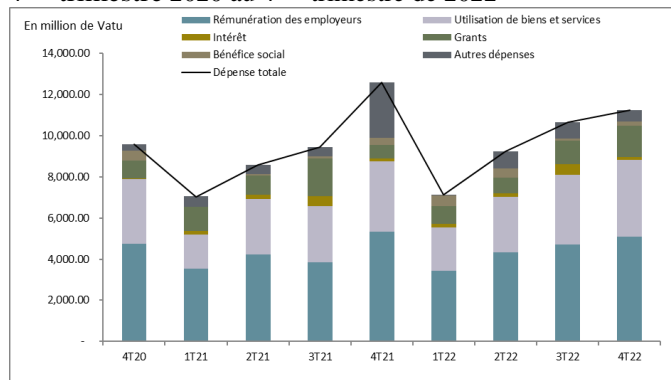
## Les Dépenses Publiques (voir le tableau 5.1)

- Les dépenses totales des administrations publiques au cours du 4<sup>ème</sup> trimestre 2022 se sont élevées à 11 253 millions de vatu. La rémunération des salariés a représenté 45 %, soit 5 101 millions de vatu, des dépenses totales des administrations publiques au cours du 4<sup>ème</sup> trimestre de 2022. Il s'agit d'une augmentation de 8% par rapport au trimestre précédent, mais d'une diminution d'e 4% par rapport au 4<sup>ème</sup> trimestre 2021.

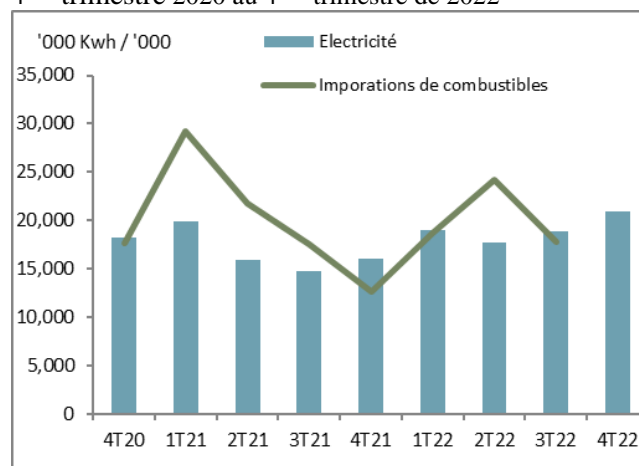
